Subj: I MARINE EXPEDITIONARY FORCE (FORWARD) POLICY ON SOLICITATION OF

GIFT

- 1. Situation. I Marine Expeditionary Force (Forward) [I MEF (Fwd)] has experienced service members soliciting gifts of equipment and supplies from outside entities. Soliciting includes asking for or requesting donations or gifts of property or money. In general, service members are prohibited from soliciting gifts. Per references (a), (b), and (c), a service member shall not, directly or indirectly, solicit or accept a gift from a prohibited source. Reference (d) is a pre-deployment letter outlining guidance regarding the acceptance of gifts by I MEF (Fwd) units, but due to continued issues, this Policy letter is published to re-emphasize the importance of abiding by regulations.
- 2. $\underline{\text{Mission}}$. To establish the I MEF (Fwd) policy on solicitation of gifts.
- 3. Execution. All personnel and units shall follow the guidance outlined in the references.
- a. At no time will any member of I MEF (Fwd), to include subordinate commands, solicit an individual or other entity outside this command for a gift or good of any kind without prior authorization through the chain of command to the Commandant of the Marine Corps (CMC) or Secretary of the Navy (SECNAV) levels. Service members will not indirectly, through an individual or other entity, solicit a gift or good of any kind from any source.
- b. Charitable organizations that donate incidental items to deployed service members (i.e. care packages) that are not meant for a specific individual are exempt from consideration as a prohibited gift. Directly or indirectly, service members may not request, ask for, or solicit the sending of care packages. If charitable organizations or individuals intend to send care packages on their own volition, service members may not request particular items be included.

- c. Use of the Marine Corps Supply System is the approved process for purchase of required items/equipment.

5. Command and Signal

- a. <u>Command</u>. This Policy is applicable to all forces under the operational control of the Commanding General, I MEF (Fwd).
